

VIDEO RECORDS COMMITTEE (JOHN GOSS)

Video Record Interviews of Emeriti and Campus Administrators began in 1993. At June 2006, 293 interviews had been conducted. A tape or DVD has been deposited in the Special Collections in the Shields Library which can be "checked out" at the Special Collections desk.

A special S-VHS tape is made for the weekly showing (by permission of the interviewee) on Channel 15, Davis Community Television starting at 8:30 pm each Tuesday. Please see the Spotlight Section of the Davis Enterprise for the weekly Channel 15 Schedule. New interviewees are notified by Chair Goss of the date for the showing of his or her interview.

New digital tape copying equipment was purchased with Emeriti Association funds during May, 2005 and is now used to produce DVD records for the Shields Library, interviewee and interviewer. If needed by the interviewee or interviewer, VHS tapes or CDs can be provided.

To view the table, wait a few moments for the table to appear in the active window.

The interviews can be scheduled for Tuesday or Thursday at 10 AM or 11:30 AM in Room 65 in the basement of Mrak Hall from September through the following June. Interviews can be 50 to 55 minutes long. The interviewee selects his or her interviewer. The less than hour long interviews are recorded on digital camera caches. The camera records are read into computer files from which they are edited and copied onto video tapes, DVDs, or CDs.

The Committee invites all Emeriti who have not been interviewed to schedule their own interview with Jim DeVay (752-7310) Campus Phone or (753-2224) Residence Phone. He will provide the schedule for open interview dates.

The closest and most likely available parking for the interview days is the South Entry Parking Structure on

the South side of the Mondavi Center. It is a 5 to 10 minute walk to the basement of Mrak Hall. Money is available in Room 65 for reimbursing round - trip taxi fare for interviewee and interviewer not having personal transportation, or if the distance to walk is burdensome. There are four (4) Handicapped Parking spaces in the parking area on the West side of Mrak Hall. Please call Chair Goss to arrange for a reserved Handicapped Parking space for the interview date.

The 2005-2006 Panunzio Distinguished Emeriti Award Charles E. Hess

David Easton, Distinguished Professor of Political Science at the University of California, Irvine was honored with the 2005-2006 Constantine Panunzio Distinguished Emeriti Award. The award acknowledged nearly two post-retirement decades of outstanding scholarship and extraordinary contributions to UCI's intellectual life and reputation. Among other achievements, he was instrumental in bringing the Western Office of the American Academy of Arts and Sciences to Irvine and in the development of the Interdisciplinary Center for the Scientific Study of Ethics and Morality.

Since his official retirement, Professor Easton has published 25 articles and six books extending his record of scholarship in the applications of systems theory to political science. In 1996, two awards were established in his name: the David Easton Prize for Graduate Studies at UC Irvine and the American Political Science Association's David Easton Award which honor the best work done in empirical political theory, a field he pioneered. That same year, Professor Easton received the Alexander van Humboldt Research Prize honoring the lifetime academic achievements of internationally respected scientists.

Two UC Davis emerita have received the Panunzio Award. Emmy Werner, Human and Community Development, received the Award in 1999-2000 and Sarah Hrdy was the 2002-2003 recipient. Emeriti(a) are invited to nominate colleagues for the 2006-2007 Panunzio Distinguished Emeriti Award. The award honors outstanding scholarly work or educational service (e.g. service in professional, University, Academic Senate, emeriti, departmental, or editorial posts or committees) performed by a University of California emeritus or emerita in the <u>humanities or social sciences</u> since retirement. Nominations should be sent to Richard Walters, President of the UCDEA, by November 13, 2006.

The UC Davis Retiree Center Advisory Committee (AC) is in its second year of operation. An annual report of the first year's activities can be found on the webpage of the Center (<u>http://retireecenter.ucdavis.edu</u>) - click on "Reports."

The major activity of the AC in the past year was the preparation of a job description and the recruitment of the Retiree Center Coordinator, Doreen Barcellona Strnad. The Committee has representatives from the UCD Retirees' Association (UCDRA), the UCD Emeriti Association (UCDEA),and a representative from retirees who are not members of either organization. Other members include human relations representatives from the campus and the UCDHS, and representatives from the Chancellor/Provost's Office.

The AC will meet monthly during the start up of the Center. It provides advice to the Coordinator about the operation of the Center and the division of responsibilities among the Center, the UCDRA and the UCDEA. The AC is working with Coordinator Strnad on the development of accurate lists of all retiree retirees, and the membership of the Retirees' and Emeriti organization. A webpage has been launched for the Center, the UCDEA webpage has been updated, and a web page for the UCDRA will be developed.

Other projects include the publishing of *EmeriTimes* and *The UCD Retiree*, the two organization newsletters; an Open House when the Retiree Center moves into the Everson Hall location, Picnic Day festivities, and special events such as a possible reincarnation of the Steak Bake next spring. Another new project may be the development of a clearing house to keep retirees informed about part time employment opportunities, and in return, keep the campus informed about the skills of retirees interested in part time work.

UC Davis Centennial Celebration: 2008-2009
